3. The fund may invest in Sukuk and other Shari'ah Compliant Products.

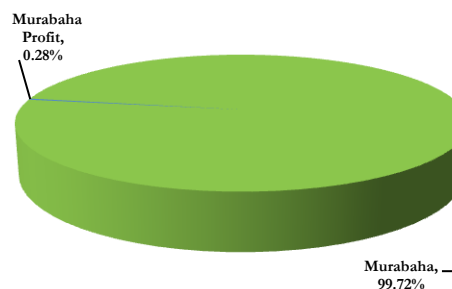

Asset Allocation

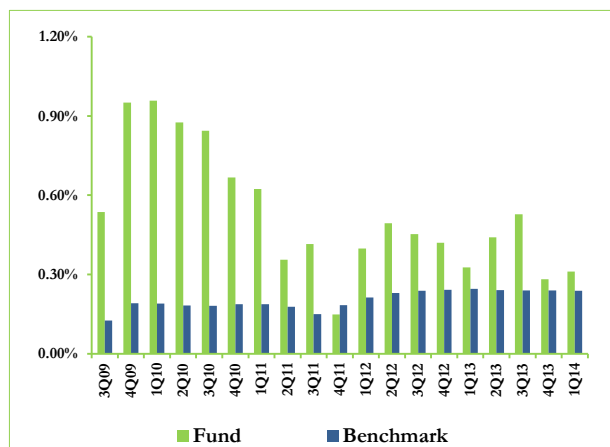

The Investor Murabaha Fund's NAV reached to SAR 11.05 for the first quarter ended 31st March 2014, registering thereby a Since Inception growth of 10.51%. SAR 3 month SAIBOR the Fund's benchmark has remained same at 95 basis point as it was at the end of last quarter and thus recorded a positive performance of 0.24% for the first quarter ended 31st March 2014. It is noteworthy that the interest rates in the Kingdom are heavily influenced by the interest rates in the US. The Investor Murabaha Fund has outperformed the benchmark by 0.07% in first quarter 2014 and 6.56% since inception.
